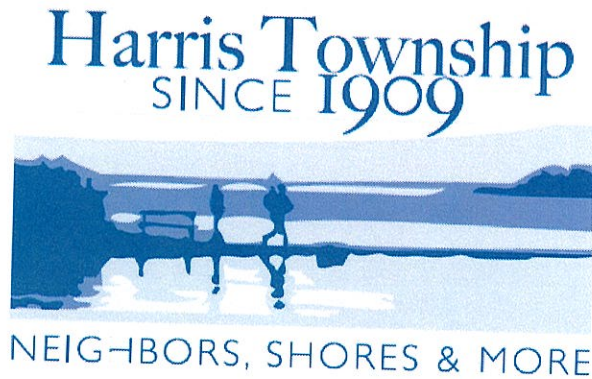

**RESOLUTION #2020-024  
 A RESOLUTION ADOPTING CARES ACT FUND EXPENDITURES**

**WHEREAS**, On January 26, 2020 Governor Waltz ordered CARES Act funding to townships; and

**WHEREAS**, Harris Township has a population under 4,999 and received \$25.00 per person, for a total of \$81,425.00; and

**WHEREAS**, Harris Township, in keeping with the guidelines set forth, Harris Township certified how they intended to use the money to cover costs related to the pandemic that were not accounted for in budgets; and

**WHEREAS**, Harris Town Board approved and authorized the spending of \$81,425 at their September 9, 2020 Regular Board Meeting; and

**WHEREAS**, Harris Township has purchased: laptops for 5 supervisors, and updated the Clerk and Treasurer Laptop; Antivirus and Office Suite 365 for said laptops; upgraded the Xerox copier at the town hall; cleaning supplies, and tables; double-door automatic operator for the main hall entrance (to include electrician costs); cement ramp for the emergency exit door of the hall (to include needed work on emergency exit door; security at Crystal Park, Wendigo Park, Service Center, and Harris Cemetery; laminating of elections signage; stackable washer and dryer; (to include electrical installation), and Mediacom Wi-Fi set up at Crystal Park and Wendigo Park (to include transfer of current phones from Century Link to Mediacom); and

**NOW THEREFORE BE IT RESOLVED**, Harris Town Board completed Local Government Expenditure Reports, with explanations of each purchase, to Minnesota Management and Budget (MMB) with said reports on file with the Clerk of Harris Township; and

**NOW THEREFORE BE IT FURTHER RESOLVED**, Harris Township Board of Supervisors hereby adopts Resolution #2020-025.
